

A Quasi-Monte Carlo overview

Quasi-Monte Carlo methods are becoming a practical tool for numerical integration in high dimensions, in many cases provably outperforming Monte Carlo methods. Applications range from option pricing to partial differential equations with random coefficients. Their role in function approximation has long been recognized, but is much less well developed. In this talk I will give an overview of recent developments.
