Self-similarity in the eigenvalues of random matrices

The eigenvalues of random unitary matrices have long been conjectured to have a selfsimilarity property: that n sequential eigenvalues of an mn \times mn random unitary matrix are statistically indistinguishable from the eigenvalues of an n \times n random unitary matrix. I will describe a first rigorous result on this phenomenon.
